International Partnership

The Transportation Pooled Fund (TPF) program is a collaborative research program that has existed for more than 45 years. TPF creates an opportunity for partners to pool their funds, subject matter expertise, and resources to conduct high-priority research that addresses a wide variety of shared transportation problems. Since 2003, the TPF program has processed more than \$656 million in collaborative research funding, and, as of February 2023, has 152 active projects and 18 open solicitations (170 in total).



The TPF program has partnered with 19 different global partners since 2003.

How to Participate

International agencies interested in participating should request access from the TPF program manager to view and log into the TPF website (<u>https://www.pooledfund.org/</u>) where they can join potential TPF studies. Once international users are given TPF website access, they can review TPF research project content and decide which ones they would like to participate in.

Developed in conjunction with FHWA, the American Association of State Highway and Transportation Officials, and State DOTs under the National Cooperative Highway Research Program Project 20-39(2), the TPF interactive website includes all current projects and TPF program resources. It serves as an excellent tool for tracking research activity and a resource for reviewing projects of interest.

How to Transfer Funds

For an international agency interested in providing funds to a TPF research study, the contribution process depends on whether FHWA or a State DOT is leading the study.

For FHWA-led projects, foreign government funds can be transferred through a mailed check (in U.S. dollars) or an online fund transfer service, such as Pay.gov or the Fedwire® Funds Service. Detailed procedures for sending non-Federal funds can be found in the <u>TPF Procedures Manual (March 2023)</u> document on the TPF website's "<u>Frequently Used</u> <u>Resources</u>" web page.

For State DOT-led projects, the transfer of funds is handled between the State DOT and the country involved. Unless a fund transfer is agreed upon, a mailed check (in U.S. dollars) must be sent to the State DOT leading a TPF study.
