# Overview Guide for the Tribal Transportation Program Online Reporting Tool (PORT)

The following document is a pdf version of the online reports, intended to help familiarize you with the Tribal Transportation Program Online Reporting Tool (PORT). Welcome to the Overview Guide for the Tribal Transportation Program Online Reporting Tool, more commonly known by its acronym PORT. PORT is used to fulfill the requirements of Section 117a of the FAST Act, requiring annual reports to Secretaries of the Department of the Interior and the Department of Transportation. The following steps provide an overview instructions for how Tribes interact with PORT:

- Step 1. Receive a reporting keychain for the Tribe you represent from your BIA or FHWA TTP point of contact (POC). The reporting keychain is a document containing links to the online reports that can be completed and submitted online. These online reports include a financial report, a non-construction activities report and project reports.
- Step 2. Complete the online reports. A financial report and non-construction activities report are mandatory and must be completed for the reporting period. Project reports must be completed for each project that was active (in either project development or construction) during the reporting period.
- **Step 3.** While completing the reports, ensure that you click the "Next", "Previous", or "Resume Later" buttons every 20-minutes to ensure your work is saved. Also ensure that a reporting link is only open on a single computer at any given time. If a reporting link is open on two or more computers, information would be overwritten by the last copy saved.
- **Step 4.** Receive a confirmation email for each report you submit. A copy will also be sent to your BIA or FHWA point of contact.

Much effort has been made to make questions within PORT clear and concise. The remainder of this overview guide consists of images from PORT with blue text added to provide clarification where possible. A reporting keychain is received from your agency POC. The reporting keychain provides links to required reports and is customized, reflecting projects that appear on a Tribe's Tribal Transportation Improvement Program (TTIP). The reporting keychains are unique to the current reporting period; reporting keychains from prior reporting periods will not provide access.

- 1. The Financial Report and Non-Construction Activities Report are <u>required</u> each reporting period and each of these reports must be completed.
- 2. The Tribe's design and construction projects from their approved TTIP determines the number of Project Report links a Tribe receives, with project information from the TTIP automatically loaded into these Project Reports. <u>Only projects that were active during the reporting period need to be reported on</u>. An active project is one with expenditures on project development or construction within the reporting period.
- 3. Five additional Project Report links are provided for projects that aren't listed.

As you're completing the online report, at the bottom of each page you'll see buttons titled "resume later", "previous" and "next". One of these buttons need to be hit <u>every twenty minutes or less</u> to ensure the system doesn't time out and lose entered data. If you need to step away from the survey, please use these buttons to ensure your work is saved. "Previous" and "next" allow you to navigate between sections of a report. On the final page of a report, the "submit" button will process the report. If you have changes to make after submitting a report, you can access and edit the report again through the keychain reporting link and then resubmit the report. Confirmation emails will be distributed after every submittal.





When clicking a report link on the reporting keychain, you may be redirected to the screen shown above stating "token mismatch." This is a glitch within the max.gov system. By hitting the refresh button on your internet browser (the arrow in a circle generally located on the left or right of the web address, as pointed to by the red arrow below), you should be redirected to the report page.



#### **BASIC INFO PAGE 1**

A Basic Info screen will be displayed when a reporting link is selected. This page will be identical for all report types, with the exception that non-construction activity reports allow for the Tribe's info to be edited (see page 10 below). The reporting period is identifed along with emails that will receive copies of the report when submitted. Emails should be listed for and automatically distributed to the agency's TTP contact list for the Tribe, as well as a copy to the Agency point of contact for the Tribe. An additional email address can be added here. If for some reason a confirmation email wasn't sent to one of the Tribal addresses listed or you wish to forward to another Tribal staff, the email can be forwarded by a Tribal recipient or by the agency POC.
