Construction Activities and Upcoming Work

Since the last newsletter, 8/4/2023, the following work has taken place on the Upper Hoh River Road Phase 2 project:

- Completion of the temporary shoring wall system for first phase of the MP 4 box culvert installation, allowing for excavation to the foundation of the new culvert, while still maintaining a bypass lane for traffic.
- Installation of the work isolation and flow diversion system along the bank of the Hoh River at the outlet of the MP 4 box culvert, allowing for diversion of surface and ground water from the work site.
- Placement of the outlet sections of the 18ft tall x 20ft wide box culvert.
- Backfill of streambed material inside the culvert and at the outlet of the culvert
- Removal of the Hoh River work isolation and flow diversion system.
- Backfill of the roadway embankment on both sides of the culvert to re-establish the roadway alignment over the new culvert.
- Completion of 8 Engineered Log Jams (ELJs) at MP 3.5, completing all the ELJs that will be built for this project.

Construction Activities and Upcoming Work

The following work is upcoming in the next couple of weeks:

- Swap traffic from the current bypass lane on the north side of the road to the south side, over the new MP 4 box culvert. This will allow installation of the remaining third of the culvert
- Complete temporary shoring wall for the next phase of culvert installation
- Excavate to the foundation elevation for the rest of the culvert
- Place the remaining sections of the box culvert and backfill
- Construct the Wetland Mitigation Site at MP 3.5
- Asphalt paving at the MP 4 box culvert and MP 7.8 Tower Creek sites

Impacts to Traffic

- One lane traffic with flaggers and/or temporary traffic signals at milepost 4 of Upper Hoh Road for culvert installation
- Expect delays up to a total of **30 minutes** per passage through the project corridor from **8AM-5PM**.
- Access to the Hoh Rain Forest Visitor Center and businesses along Upper Hoh Rd. remain accessible at all times during construction.


