

## RUMBLE STRIP IMPLEMENTATION GUIDE: ADDRESSING BICYCLE ISSUES ON TWO-LANE ROADS



This guide serves to educate safety, planning, and design professionals about the need to collaborate with the bicycle community and understand the functional and safety needs of bicyclists as edge line, shoulder, and even center line rumble strips are being considered for implementation. The guide presents design flexibilities on bicyclist accommodation that have been used by agencies with successful large-scale implementation of rumble strips on two-lane rural roads.

#### Introduction

Longitudinal rumble strips are an effective, low-cost countermeasure for preventing roadway departure crashes, including both run-off-road and opposite direction sideswipe crashes. Rumble strips<sup>1,2</sup> are milled or raised patterns near the center line or edge line of the roadway that provide both an audible warning (rumbling sound) and a physical vibration to alert drivers that they are crossing into opposing traffic or leaving the roadway. Rumble strips placed underneath center line or edge line striping are referred to as "rumble stripes."

**Rumble Strip Basics.** There are two main applications for rumble strips:<sup>3</sup>

• Shoulder rumble strips and edge line rumble stripes (shown in Figure 1) are primarily used to prevent run-off-theroad (ROR) crashes by warning drivers that they are drifting onto the roadside. While shoulder and edge line rumble strips perform the same function, the placement sets them apart. Shoulder rumble strips are historically common on freeways and other divided highways, but the decision to use one or the other on two-lane roads is made based on

a number of factors. The edge line rumble stripe aligns the rumble strip with the pavement marking and thereby improves the visibility of the marking in wet, dark conditions. By placing the rumble strip closer to the travel lane it

alerts the driver sooner that they are leaving the roadway. Shoulder rumble strips and edge line rumble stripes have been shown to reduce single vehicle, run-off-road fatal and injury crashes by 29 percent on rural two-lane roads.<sup>4</sup>

center line rumble strips or stripes (shown in Figure 2) can prevent head-on collisions and opposite-direction side-swipes, often referred to as cross-center line crashes. They are primarily used to warn drivers who are drifting into an opposing travel lane. While they are most often used on rural two-

lane, two-way roadways, they can also be applied to multilane, undivided facilities. Center line markings are typically placed on center line rumble strips, which have an added benefit of improving the visibility of the marking in wet, dark conditions. Center line rumble strips have been shown to reduce head-on and opposite-direction fatal and injury crashes by 44 percent on rural two-lane roads.<sup>5</sup>

**Rumble Strip Challenges for Bicyclists.** Whether riding in the lane or on the shoulder, bicyclists are legal road users and have the right to use the roadway. Rumble strips can pose challenges to bicyclists if their needs are not considered. It is important to keep in mind that bicyclists have varying abilities.

Experienced riders prefer a direct route and are comfortable riding with the flow of traffic and using the full width of narrow travel lanes when appropriate. Casual and less confident riders typically ride more slowly and may use a less direct route to avoid heavy traffic. The equipment also varies, from very light bikes with high-pressure tires that may be damaged by roadway debris to heavy-duty bikes with wide tires that can easily ride on a gravel shoulder.

Traversing rumble strips on a bicycle can be uncomfortable and could possibly lead to loss of control. Gaps in the rumble strip are provided to allow bicyclists to travel between the shoulder and the travel lane, to turn left, and to avoid debris or other obstacles in their path. Depending on the size and location, a shoulder rumble strip may remove the shoulder as an option for bicycle travel. Center line rumble strips are less problematic, the primary concerns being that drivers may be less likely to cross the rumble strips to pass a bicyclist or that drivers may move away from the rumble strip, closer to where the bicyclist is likely to be traveling. The strategic placement and design of edge line, shoulder, or center line rumble strips is important as practitioners balance safety improvements and increasing the viability of alternative modes of transportation.

#### **Rumble Strip Considerations for Bicyclists**

While rumble strips provide many safety benefits for motor vehicles, they can present rideability issues for bicyclists. A paved shoulder is often the safest location for bicycle travel, particularly on roadways with higher operating speeds than those typically achieved by bicyclists. However, bicyclists may utilize the travel lane or alternate between the shoulder and travel lane depending on conditions. Designated bicycle routes<sup>6</sup> and other roadways with known frequent bicycle traffic may warrant special consideration regarding the effects of adding rumble strips. Flexibility in application is available on all roadways, but the extent of current and projected bicycle traffic may help agencies prioritize where to employ alternative design options to better accommodate bicyclists and increase use of rumble strips beyond the standard practices.

Rumble strips are most effective on or very near the edge of the travel lane<sup>7</sup> both because they provide more alerting noise and vibration at shallower departure angles and because the sooner the driver is alerted that he or she is leaving the travel lane, the more likely a recovery maneuver is to succeed. However, the 2 or 3 feet of shoulder nearest the travel lane is also a preferred location for bicyclists in some cases, as it is out of the travel lane and there is less likely to be debris.

The 2012 AASHTO Guide for the Development of Bicycle Facilities states that "rumble strips are not recommended on shoulders used by bicyclists unless there is a minimum clear path of 4 feet from the rumble strip to the outside edge of a paved shoulder, or 5 feet to the adjacent curb, guardrail, or other obstacle." Many DOTs have policies or guidance for edge line or shoulder rumble strips where there is sufficient existing paved shoulder width beyond it for the bicyclist to travel. However, agencies need not limit themselves to use on roadways where these standard applications provide sufficient space, as flexibility from an agency's standard rumble strip design may provide the opportunity to improve overall safety on a wider variety of roads. This option is important for reducing severe roadway departure crashes, particularly on roadways where a systemic or spot analysis indicates a safety concern. For 3R (resurfacing, restoration, or rehabilitation) projects where identified safety concerns exist or for safety projects, agencies may also want to consider these alternative design options even if the full standard width beyond the rumble strip cannot be attained. The goal is to optimize safety for all road users. The needs of bicyclists and the tradeoffs in safety effectiveness of alternative rumble strip designs can be considered, along with other concerns (such as noise and pavement integrity), to determine the best design for each corridor on a project-byproject basis.

#### Providing Rideable Space beyond the Rumble Strip

Shoulders are a proven safety feature for all road users, but are particularly beneficial in reducing conflicts between slower traffic and those vehicles traveling at typical highway speeds. The presence, composition, and integrity of the shoulder surface can affect where a bicyclist chooses to travel. Many bicyclists prefer to use the shoulder when it is paved and well maintained. If a shoulder is not paved, it is more likely that bicyclists will ride in the travel lane, even when vehicles are passing them.

Paving existing unpaved shoulders or widening existing shoulders may be the best overall safety solution in some locations. However, unless the highway segment is being reconstructed, the cost and environmental impact of widening the roadway cross-section for any significant length of a roadway corridor is often prohibitive. Permeable pavements that are currently being studied for other uses hold some promise for future shoulder widening with less impact. A solution frequently used by DOTs is to adjust the location and the size of the rumble strips. Many States have begun installing narrower (12 inches or 8 inches) rumble strips, rather than the previous standard of 18 inches to provide more room on the shoulder for bicyclists. Even narrower rumble strips have been used under the assumption that some warning is better than none. It is expected that there will be reduced safety effectiveness by narrowing the rumble strip, but widths under 12-inches have not been studied to any extent at this time. Installation of edge line rumble stripes has also become a somewhat common practice, which provides multiple benefits:

• Edge line rumble stripes may afford bicyclists additional travel width by shifting the rumble strips from 6 inches to 2 feet closer to the travel lane.

- Roads with edge line rumble stripes are more likely to have rideable shoulder space that is free of debris.
- The noise associated with vehicles passing over the edge line rumble stripe can act as an "alert" to bicyclists that vehicles are encroaching on the shoulder, and it improves the likelihood that the motorist will return to their lane before leaving the roadway.

The way in which these potential design modifications (changing the size or location) are accomplished varies:

- It may be done as a standard practice or on a case-bycase basis.
- It may depend on the classification of the roadway or the paved lane and shoulder widths.

Figure 3 shows an example of an early rumble strip installation where the offset was 12 inches from the edge line and 16-inch rumbles were used, leaving only 2 to 3 feet for bicyclists. Current

installations use 12-inch rumble strips with either a 6-inch offset or an edge line rumble stripe to provide an additional 10 to 16 inches of space for bicyclists traveling on the shoulder.

States vary slightly in their preference for shoulder rumble strips or edge line rumble stripes. States' standard practices also vary in the minimum shoulder width requirements for installing either type of rumble strip or stripe. Typical minimum shoulder width requirements are between 4 and 6 feet.

- The policy in both Missouri and Idaho is to install edge line rumble stripes in order to provide a debris-free area on the shoulder side of the rumble strip for bicyclists. This placement also provides an audible warning to the bicyclists if a vehicle is coming over the edge line. Missouri DOT typically uses edge line rumble stripes in areas of high bicycle traffic in order to address some of the concerns associated with shoulder rumble strips.<sup>8</sup>
- South Carolina DOT uses shoulder rumble strips on controlled access roads and edge line rumble stripes on all other roads.<sup>9</sup>
- Pennsylvania DOT's policy is to install shoulder rumble strips if the paved shoulder is 6 feet or greater in width, and edge line rumble stripes if the paved shoulder is between 4 and 6 feet. The policy also requires at least 11-foot wide lanes.<sup>10</sup>

 Michigan DOT's policy requires a minimum of a 6 foot paved shoulder in order to install shoulder rumble strips. Edge line rumble stripes are not commonly used in Michigan.

Arizona DOT also reviewed roadways where bicycles are allowed (i.e., non-urban Interstate) and identified all locations where rumble strips are installed with less than 4 feet of effective shoulder width on the "Cycle Arizona Bicycle User Map." This map helps bicyclists chose specific routes that meet their individual needs and comfort levels.<sup>12</sup>

"If safety concerns outweigh other issues such as noise and bicycle use, non-freeway centerline and shoulder corrugations can be considered for use on roadways that do not meet the criteria given above."

While center line rumble strips do not present obstacles for bicyclists, there are a few issues to consider. The AASHTO Guide for the Development of Bicycle Facilities recommends a paved surface width of 14 feet beyond a center line rumble strip, which can include the driving lane and shoulder. While there is a perception that motor vehicles shy away from center line rumble strips, studies indicate that where this occurs it is a very small shift – less than 6 inches<sup>13</sup> and where shoulders are narrow, drivers positioned the center of their vehicles closer to the center of the lane.<sup>14</sup>

Another concern is that motorists are less likely to cross a center line to pass a bicyclist at the edge of the lane or in the shoulder if there is a rumble strip on that center line. Michigan DOT conducted a field study<sup>15</sup> that found 71 percent of drivers contacted the center line rumble strips to pass a bicyclist in comparison to 79 percent of drivers that contacted the center line when there was no rumble strip present. However, the effect of the presence of rumble strips was small in comparison to the location of the bicyclist (in the travel lane, or specific placement in the shoulder) and whether there was oncoming traffic in the opposing lane.<sup>16</sup>

#### **Traversing Rumble Strips**

Another component of accommodating bicyclists using the shoulder where rumble strips are present is to provide gaps within the continuous rumble strips so that bicyclists can easily move between the shoulder and travel lane as necessary to avoid debris, make turns, pass, etc. The gaps are designed such that it is unlikely a motor vehicle will cross the line of rumble strips without alerting the driver. Most roadway departures where a rumble strip will reduce the likelihood or severity of a crash involve a low angle of departure (the driver drifts off the road as opposed to steering sharply to avoid an animal). A properly designed pattern considers the size of the rumble strips and the gap pattern. Since the gap exists entirely for use by bicyclists, the design should also consider how much space a cyclist needs to pass between the gaps, which may vary on steep grades. Gaps are not always needed but are encouraged, even when the surface on the other side of the rumble strip is not ideal for cycling.

Michigan, Pennsylvania, South Carolina, Tennessee, and Washington DOTs all reported using a pattern with 10- to 12-foot gaps in every 40 to 60 feet of continuous rumble strips. Pennsylvania DOT does not require bicycle gaps and leaves the decision at the engineer's discretion or on a case-by-case basis.<sup>17</sup>




FIGURE 4. Example of Bicycle Gap.

Figure 4 shows a typical example of rumble strips with a gap for bicyclists.

Reducing the depth of the rumble strip is an alternative design to provide a rumble strip design that is less jarring to bicyclists as they need to cross from the shoulder to the lane or viceversa. This practice has become less common as the bicycle gap has gained popularity. Pennsylvania DOT uses shallower rumble strips (5/16 inch) at locations where additional bicycle considerations are needed.<sup>18</sup>

In Washington State, whether the road is undivided or divided is a determining factor for rumble strip depth. On undivided highways, where bicycle traffic is greater in the State, the typical rumble strip depth is 3/8 inch, whereas on divided highways, it is 1/2 inch to 5/8 inch. Washington State DOT allows a large annual bicycle race to utilize the same roadway every year. Due to the large size of the race and the negative effects they could cause the bicyclists during the race, the DOT decided not to install rumble strips on this roadway. This is an isolated, unique situation, and is a good example of tradeoffs being considered on a case-by-case basis.

It is important to understand the exact concerns of the bicycling community, to be flexible regarding the implementation and design of rumble strips, and to maintain dialogue with the bicycle community and other road users.

#### **Collaboration and Outreach**

As agencies consider installing edge line or shoulder rumble strips, public outreach to and involvement of the bicycle community is essential.

In Michigan, the bicycle community, particularly the League of Michigan Bicyclists (LMB), collaborated with Wayne State University on the first phase of their research on the impact of non-freeway rumble strips. <sup>20</sup> The LMB's website was used to survey bicyclists' opinions of rumble strip design-related issues. The LMB also worked with the Michigan DOT (MDOT) to create a "Share the Road" public service announcement to help drivers understand safe practices related to passing bicyclists where rumble strips exist. <sup>21</sup> "Share the Road" signs were installed, but they have not been shown to have any significant effect on driver behavior.

South Carolina DOT (SCDOT) developed a public marketing campaign, "Recognize-React-Recover" that seeks to educate the public on rumble strip safety benefits and how to react when leaving the roadway. In this campaign, SCDOT recognized the importance of engaging the bicycle community during the transportation planning phase and as an ongoing effort. SCDOT routinely engages the bicycle community, and before rumble strips are recommended for installation on designated bike routes, conducts crash analyses and discusses findings and recommendations with bicycle advocacy groups. Using this process, SCDOT has been successful in gaining the support

of the bicycle community without having to exclude the application of rumble strips on designated bike routes. <sup>22</sup>

Pennsylvania DOT and Washington State DOT collaborate with bicycle advisory committees when planning, developing policies, and making implementation decisions regarding rumble strips. Since these groups typically have diverse representation, the DOTs receive comprehensive input and feedback. It is important to understand the exact concerns of the bicycling community, to be flexible regarding the implementation and design of rumble strips, and to maintain dialogue with the bicycle community and other road users.<sup>23</sup>

#### **Summary**

Edge line (or shoulder) and center line rumble strips are very effective at reducing severe motor vehicle crashes. Their use can, however, present challenges for bicyclists safely sharing the roadway. Where existing pavement widths do not readily accommodate both rumble strips and bicyclists, there are a number of ways to optimize safety for all road users. Paving or widening shoulders, while often providing the greatest overall safety benefit, is often not feasible with available funds. In those situations, flexibility in the design of rumble strips may be adequate to reduce the impacts to bicyclists.

Shoulder rumble strips can be installed at the edge of the travel lane, which widens the available space for bicyclists and may provide a more debris-free ride. Depending on the standard design of an agency, narrower rumble strips may still be effective to alert drivers of passenger vehicles while providing several extra inches that may be useful to a bicyclist riding on a rather narrow shoulder. Bicycle gaps are a design feature that is encouraged in most situations where bicyclists are likely to be using a corridor. These design modifications have been used to varying degrees by many State DOTs, both as a standard practice and on a case-by-case basis, to improve their highways. Many States have also found that working with bicycle groups to understand their needs as road users, educating them on the safety benefits of rumble strips, and addressing the bicycle community's concerns when implementing policies is critical to the successful implementation of this safety countermeasure.
