Construction Activities & Upcoming Work

Work continues on FSR 354 and will continue through out the month of May, Monday thru Friday from 7am-5pm PDT. Work will consist of clearing and grubbing, roadway and embankment excavation, road realignment and construction of a rock buttress at M.P. 13.6. The project site conditions are two track gravel roads with limited pull outs. The current phase of work is Roadway Excavation and the roadway is completely block at M.P. 13.6. Please be aware of the construction operations in progress and refrain from entering the project area.

Road Closures

FSR 354 will be closed to the public while construction operations are completed through out the month. The road closure is intended to stay in place during weekends which may include the Memorial Day Holiday from the bridge at the intersection of Main Slate Creek Rd (FSR 354) and Little Slate Creek Road (M.P. 12.8 to M.P. 15.9). Slate Creek road towards Nutt Basin will remain open. No traffic delays are anticipated however, there will be heavy truck traffic, typically in the mornings and afternoons as the Contractor arrives to the project location and leaves at night.


