# **Construction Activities & Upcoming Work**

# **Project Description:**

Utilizing Great American Outdoor Act Funding the Yellowstone River Bridge project includes constructing a new bridge over the Yellowstone River, a new alignment to the bridge approach, expansion of picnic areas, and additional parking at various trailheads.

### **Road Conditions:**

Extreme caution should be used by motorist and tourist, particularly during rainy or snowy weather conditions. Temporary traffic control signs are utilized at the active construction locations to ensure public safety.

# **Current and Upcoming Work:**

The contractor has completed all of the post tensioning and wax injection at Pier 1. The isolation bearing pads will be installed at Pier 1 over the next few weeks. Post tensioning and wax injection for all the piers is now finished. The contractor is currently constructing the embankment at Pier 1 and installing a crane pad for the next stage in the girder erection process. The contractor has completed girders C, D, and E from Pier 3 to Pier 2 this week, and continue to focus on completing installation across the river over the weekend.

As we near the end of the season, the girder erection process and winter site prep are all that remains.

# **Traffic Delays:**

Minimal delays should be expected next week and the majority of the construction season. Please use caution when driving by construction access roads.
