

- Began in 1983 as the Indian Reservation Roads (IRR)
   Program.
- Jointly managed and administered by BIA and FHWA
- Serves 574\* Federally recognized Tribes.

# How much of the TTP Tribal shares go to Tribes?



- The other parts are:
  - 2% for Planning
  - 3% for Bridge program.
  - 2% for Safety program.
  - 5 % PM&O FHWA & BIA inherent federal functions.
  - Obligation Limitation, not available for use, changes each year..

# Indian Tribal governments choices in the delivery of the TTP program



## **Option 1: BIA Direct Services**

 Tribe agrees with BIA which activities will be delivered by the Region.

### **Option 2: BIA PL93-638 Contracts**

- Contracting with the Tribes for programs and services provided by Bureau of Indian Affairs
- Contracting with the Tribes for construction projects provided by the Bureau of Indian Affairs
- Oversight of the audits submitted by the Tribes.
- Provide Technical Assistance to the Tribes in the region.

# Option 3: Tribal Transportation Program Agreements

- A Tribe with a TTPA administers its own Tribal Transportation Program (TTP).
- Transfer to the Tribe all the functions and duties that the Secretary would have performed with respect to a program or project under Chapter 2 of Title 23, other than those that cannot be legally transferred.
- Tribe carry out the statutory requirements pursuant to the FAST Act.
- Provide the Tribe or its designee, under a Referenced Funding Agreement (RFA), its share of TTP funds pursuant to the FAST Act and 25 CFR 170.
- Allows Tribes the option of working directly with the FHWA or BIA in the administration of their Tribal Transportation Program.

### **Option 4: DOI Office of Self Governance**

- The Office is responsible for implementation of the Tribal Self Governance Act of 1994.
- The Office provides financial management, budgeting, accounting and contracting services for funds that are allocated or awarded to self-governance tribes
- The Office works with tribal governments to protect and support tribal sovereignty within a Government-to-Government partnership and to advocate for the transfer of Federal programmatic authorities and resources to tribal governments in accordance with tribal self-governance statutes and policies.


# Option 5: Tribal Transportation Self-Governance Program (TTSGP)

- The Tribal Transportation Self-Governance Program (TTSGP)
   provides federally recognized Tribes and Tribal organizations with
   greater control, flexibility, and decision-making authority over
   federal funds used to carry out tribal transportation programs
- The TTSGP was authorized by Section 1121 of the Fixing America's Surface Transportation Act, Pub. L. 114-94. Section 1121 is codified at 23 U.S.C. § 207. As directed by 23 U.S.C. 207, the Department developed the TTSGP regulation through a negotiated rulemaking with Tribe and Tribal organization representatives under the procedures of the Negotiated Rulemaking Act.
- The TTSGP final rule becomes effective on October 1, 2020.

AGENCY: Bureau of Indian Affairs.

ACTION: Final rule.

SUMMARY: This final rule updates the Tribal Transportation Program regulations (formerly the Indian Reservation Roads Program) to comply with statutory updates. The Tribal Transportation Program is a program to address the surface transportation needs of Tribes. This rule reflects statutory changes in the delivery options for the program, clarifies the requirements for proposed roads and access roads to be added to, or remain in, the inventory, cortain cactions that we

the Indian Reservation Roads Inventory:

· Revise certain sections of the current rule that were provided for informational purposes by removing certain sections that are no longer required by statute and adding information to direct the reader to BIA or FHWA Web sites where additional information is available.

On December 19, 2014, BIA and FHWA published a proposed rule for 25 CFR part 170 and then conducted Tribal consultation sessions at six locations throughout the country during January and February of 2015. See 79 FR 76192. Written comments on the Proposed Rule were accepted at the consultations as well as by email and mail through March 20, 2015. Before publishing the proposed rule, BIA and FHWA distributed draft revisions of 25 CFR part 170 to Tribes and published a notice of consultations on the draft revisions. These consultations were conducted at three locations in May of

2013. See 78 FR 21861 (April 12, 2013).

the Surface Transportation Assistance Act of 1982 (STAA), Pub. L. 97-424. The FLHP is a coordinated program that addresses access needs to and within Indian and other Federal lands, and the TTP continues as a funding category of this program. STAA also expanded the IRR system, as it was then known, to include Tribally-owned public roads as well as state and county-owned roads.

STAA was followed in 1987 by the Surface Transportation Uniform Relocation Assistance Act (STURAA). See Pub. L. 100-17. In 1991, Congress enacted the Intermodal Surface Transportation Efficiency Act (ISTEA), which authorized 2 percent of program funds to be used for transportation planning. See Pub. L. 102-240. ISTEA also established Indian Local Technical Assistance Program (Indian LTAP) Centers, which are now known as Tribal Technical Assistance Centers (TTACs). ISTEA was followed by the

Transportation Equity Act for the 21st Century (TEA-21), which was signed into law in 1998. See Public Law 105-178. TEA-21 authorized \$1.6 billion of



 Required if a Tribe expends more than \$750,000 total of Federal funds in a fiscal year.

### **Eligible use of TTP funds**

- Eligible Activities
- Hiring a Consultant or Contractor
- Planning
- Design
- Construction
- Maintenance

- Allowable activities can be found in 25 CFR 170, Appendix A to Subpart B and include:
  - Administration
  - Transportation Planning
  - Preliminary Engineering (Design or Project Development)
  - Construction (and Construction Engineering)
  - Transit
  - Maintenance
  - Research
- A route (road) must be in "Official" status on the NTTFI
- A Tribe may request new uses of TTP funds in writing to BIA or FHWA.

### New use of funds and eligibility

- A Tribe that proposes new uses of TTP funds must ask BIA or FHWA in writing whether the proposed use is eligible under Federal law.
- 25USC eligibility questions are addressed by BIA
- 23USC and TTP eligibility questions are addressed by FHWA

- To the extent practical BIA and FHWA must consult with the TTP Coordinating Committee.
- Final determination should be provided to the Tribe within 45 days.
- Tribes may appeal a denial of a proposed use by BIA or FHWA.
